In the event that any provision contained within this Release of Liability shall be deemed to be severable or invalid, or if any term, condition, phrase or portion of this agreement shall be determined to be unlawful or otherwise unenforceable, the remainder of this agreement shall remain in full force and effect, so long as the clause severed does not affect the intent of the parties. If a court should find that any provision of this agreement to be invalid or unenforceable, but that by limiting said provision it would become valid and enforceable, then said provision shall be deemed to be written, construed and enforced as so limited.

This Agreement shall be construed in accordance with and governed by the laws of the Commonwealth of Pennsylvania. Any controversy, dispute or disagreement arising out of or relating to this Agreement shall be brought either in Pennsylvania state court, sitting in Westmoreland County, Pennsylvania.
